4b (Code:) (Expenses \$ 136,161. including grants of \$ 119,000.) (Revenue \$) Fellowships award \$7,500 to practicing professional artists of exceptional talent and demonstrated ability. The Fellowship is a merit based, not a project based award. Recipients are selected through an open, competitive panel process. There were 15 Fellowship recipients in FY14.

4c (Code:) (Expenses \$ 103,199. including grants of \$ 74,348.) (Revenue \$) Grants for Artist Projects (GAP) provide support for artist-generated projects which include (but are not limited to) the development, completion or presentation of new work. Recipients are selected through an open, competitive panel process. There were 52 GAP recipients in FY14.
